WHAT'S IMPACTING HOSPITALITY & LEISURE?

Hospitality & Leisure has arguably been the most severely hit sector over the last few years, with first having to deal with Brexit and then from March 2020 needing to negotiate the ever changing landscape that Covid brought. Throughout Covid, businesses needed to be agile and react to the changing landscape to maximise revenue and a number of businesses have come out of the pandemic in a much stronger sales position, having identified and driven other sources of revenue.

As we come out of the pandemic, the next challenge facing the industry will be the economic climate. With inflation running at a high level and a recession on the horizon, this will most certainly have an impact on discretionary spending, such as Hospitality & Leisure.

KEY CHALLENGES



ECONOMIC IMPACT

The UK economy is currently seeing high levels of inflation, which are expected to further increase through 2022 and 2023. These high levels of inflation will affect the industry in a couple of ways, firstly with increases in costs incurred by the business, but also by consumer confidence. With high levels of inflation, it is normally discretionary spending, such as holidays, leisure activities etc. which feels the impact first and we are likely to see a reduction in hospitality and leisure spend. Business owners need to be in a position to react quickly to changes in consumer demand.



FUNDING / FINANCE

Throughout Covid, the vast majority of businesses took on additional debt, either through one of the government backed loans or through other sources. Following the initial capital and interest free periods of the government backed loans, all businesses will now be incurred interest and making capital repayments on the loans, which is adding pressure to cash flow. Business have also seen the end of the reduction in VAT rates, removal of Furlough and the rates reduction will come to an end shortly, which again will have a large impact on cash flow. All business owners need to ensure that they have a full understanding of the cash flow cycle in the business and to ensure that the business is adequately funded.

The sector is amongst those worst hit by the current skills shortages, which has been brought about by Brexit, Covid and a lack of career opportunities/focus in the industry. Businesses are seeing large increases in wage costs, as they look to retain and recruit staff and these increased costs are putting further pressure on operating margins. The industry has often lacked a focus on recruitment, retention and rewarding staff, however this needs to be a key focus areas for all businesses.



As hospitality and leisure businesses compete for demand, this has often led to reduction in prices or incentives to attract customers. We are currently seeing large increases in inflation which are affecting all costs in a business, including food, wages, utilities etc and business owners need to ensure that they have a full understanding of the cost base and to amend prices accordingly.
